



CHO4057 VGA + ANALOG AUDIO TO HDMI CONVERTER

- Application: Converts VGA + R/L audio for HDMI output
- This device allows for the transmission of VGA signals over standard HDMI cable, making it easy to implement into your existing home theater system.
- Input signal: Supports capture of SXGA (1280X1024, 50/60/75 HZ), including SGA/XGA/UGA/SXGA.
- Output signal: Supports HDMI 1280x1024
- HDCP1.2 protocol compliant. With HDCP/NOHDCP output switch.
- LED indicator: When source or sink is working, LED is lit.
- Includes DC 5V power supply.
- Audio/Video cables NOT INCLUDED.

INSTALLATION:

1. Connect VGA cable from the source to the VGA input on the converter.
2. Connect R & L audio cables from the source to the red and white audio inputs on the converter.
3. Connect HDMI cable from the HDMI output on the converter to the input on the display.
4. Connect the power supply to the converter.
5. Power on the converter using the "On/Off" switch.
