

# SKYWALKER LIMITED WARRANTY

Effective January 1, 2007

## What this warranty covers

Your Skywalker Warranty covers defects in material and workmanship in Skywalker Products. The products are serviced by **Skywalker Communications, Inc.** in the U.S.A.

## What this warranty does not cover

The Warranty does not cover (1) damage caused by accident, misuse, abuse, improper installation or operation, rental, product modification or neglect. (2) Damage occurring during shipment; (3) damage caused by repair or service performed by persons not authorized by Choice Select (4) products on which the serial number has been altered, defaced or removed;

## Who this Warranty protects

This warranty protects only the original retail purchaser of the product.

## How long the Warranty lasts

The Warranty begins on the date of purchase by the original retail purchaser. The duration of the Warranty is as follows:

## What Skywalker will do

We will repair or replace, at Skywalker's discretion, products covered by warranty at no charge for labor or materials. If the product or component must be shipped to Skywalker for warranty service, the customer may pay the initial shipping charges. If the repairs are covered by warranty Skywalker will pay the return shipping charges.

## How to get Warranty Service

(1) Take the defective item and your receipt, or other proof of purchase, to any Skywalker Communications location, or (2) Ship the defective product, prepaid, to Skywalker Communications, 9390 Veterans Memorial Parkway, O'Fallon, MO. 63366. Include a detailed description of the problem and a copy of your receipt or proof of purchase. Also, provide a complete return address.

## Limitation of Implied Warranty

ANY IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY FOR PARTICULAR PURPOSE, ARE LIMITED IN DURATION TO THE LENGTH OF THIS WARRANTY. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

## Exclusions of Damages

SKYWALKER'S LIABILITY FOR ANY DEFECTIVE PRODUCT IS LIMITED TO THE REPAIR OR REPLACEMENT OF THE PRODUCT, AT SKYWALKER'S DISCRETION. IF WE ELECT TO REPLACE THE PRODUCT, THE REPLACEMENT MAY BE A RECONDITIONED UNIT. SKYWALKER SHALL NOT BE LIABLE FOR DAMAGES BASED ON INCONVENIENCE, LOSS OF USE, LOST PROFITS, LOST SAVINGS, DAMAGE TO ANY OTHER EQUIPMENT OR OTHER ITEMS AT THE SITE OF USE, OR ANY OTHER DAMAGES WHETHER INCIDENTAL, CONSEQUENTIAL OR OTHERWISE, EVEN IN SKYWALKER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
